# Environmental science grant provides challenge gift opportunity

In early February, the family advisors of the Judith Haskell Brewer Fund of The Community Foundation Serving Richmond and Central Virginia awarded Sweet Briar College a two-part gift for its environmental science program and community garden.

The grant provides a \$500,000 outright gift over three years and a second one-to-one challenge grant that will be matched by other donors to the College. The result will be a \$1.5 million total gift to support equipment, faculty support, and endowment for program operations. The community garden will be revitalized through \$50,000 of dedicated funds.

### The Charitable Rollover Gift Available in February 2016

The Charitable IRA Rollover Gift is now permanent. You can make your 2016 Charitable IRA Rollover Gift anytime in 2016. Your 2016 Charitable IRA Rollover Gift can provide the maximum support for Sweet Briar if you make your Charitable IRA Rollover Gift this year.

#### The IRA Rollover Gift to Sweet Briar College

The Charitable IRA Rollover Gift can be made in February or any subsequent month of 2016. It provides a donor who is 70 and 1/2 or older and who has an IRA with the equivalent of a 100% income tax charitable contribution deduction.

The gift also reduces the amount that a donor must take into taxable income as an IRA minimum distribution. A donor who is required to take a 5% minimum distribution from his IRA can instead direct the minimum distribution to the Sweet Briar and reduce his taxable income.

#### **Direct from Qualifying IRAs**

The Charitable IRA Rollover Gift is made directly by the IRA custodian to Sweet Briar. The gift is a completely tax-free transfer from the IRA to Sweet Briar. The gift is not included in the donor's income and the donor receives no income tax charitable contribution deduction for the gift. The completely tax-free transfer provides the equivalent of a 100% income tax charitable deduction for the gift.

Example: Susan Smith, who is 71, has a traditional IRA with a balance of \$100,000 consisting of deductible contributions and earnings. Susan can request the IRA custodian to distribute the entire \$100,000 to Sweet Briar. Under prior law, the entire distribution of \$100,000 would have been included in Susan's income. Under the new law, the distribution of \$100,000 is a qualified charitable contribution. As a result, no amount is included in Susan's income and this gift is a completely tax-free gift to Sweet Briar.

#### **Double the Tax Smart Gift**

Susan and Robert Smith have separate IRA's and both of them are 70 and ½. Each of them can make a Charitable IRA Rollover gift of 100,000 in 2016 for a total 2016 Charitable IRA Rollover gift of 200,000 dollars.

#### Vixen Athletics Corner

The Sweet Briar College athletics department is excited to announce the addition of two varsity sports that will begin competition during the 2016 fall semester. Cross country and golf will be added to the existing slate of sports, bringing the total to eight NCAA varsity teams at Sweet Briar.

"Cross country has been a club sport at Sweet Briar College for years and visitors often tell us that we have 'the perfect campus' for a cross-country program," said director of athletics Teresa Boylan. "We believe this to be true, and we look forward to hosting many teams in the future, as well as attracting dedicated cross-country student-athletes to Sweet Briar College."

The home of Sweet Briar golf will be Poplar Grove Golf Course. Poplar Grove is located within two miles of campus and is golf legend Sam Snead's final course design.

"Mr. Frank Murphy, CEO of Poplar Grove, has been extremely supportive of this addition to our athletics program," Boylan said. "Poplar Grove's director of golf and head golf professional Tracy Newman will be the home-

course advisor to the SBC golf program as the program gets going this upcoming fall."

Sweet Briar competes in NCAA Division III and as part of the 14-member Old Dominion Athletic Conference (ODAC). Cross country is a fall sport, and Sweet Briar will become the 11th women's team vying for the ODAC Championship in the fall of 2016. The seventh women's program in the ODAC, Vixen golf will play a fall schedule before beginning the traditional season in spring 2017.

"Athletics at Sweet Briar is strong, with a spirit like no other program. I believe this year is a testament to the resilience of our amazing Sweet Briar women, every single one of them. Offering cross country and golf gives us two more teams to fill with more extraordinary scholarathletes," Boylan said.

The search for head coaches is underway for both programs and we look forward to announcing updates to these programs soon.

#### **Swimming**

The Sweet Briar College swim team concluded its season at the ODAC Championships February 12 through 14 in Greensboro, NC. The Vixens finished in seventh place with 150 pts.

Mary McDevitt broke the school record in the 100-yard breaststroke, posting a time of 1:10.57 during the preliminary round. Olive Eiley initially set the previous mark of 1:10.68 in 2000 and then McDevitt tied the record as a first-year in 2014. The Yulee, FL native finished second in the B-Finals of the 100 breast to mark the highest Vixen finish of the championships.

Senior Lydia Fleck concluded her Sweet Briar career with a third-place finish in the 200-yard butterfly B-Final with a time of 2:29.56 and a fourth-place finish in the 200 free B-Final, with a time of 2:08.03.

The Notes from Indiana column gives details from the history of Sweet Briar and the Fletcher and Williams families.

In 1928, the Board authorized a nationwide campaign to raise \$375,000 for the endowment and \$375,000 for an auditorium and gymnasium. The campaign was divided among groups much like the **Next is NOW** special initiative has been: alumnae, students, Board, faculty, the employees who were descendants of the enslaved founders of the College, friends outside the College, and the waitresses in the dining room set up their own challenge.

According to <u>The Story of Sweet Briar</u> (1956) by Martha Lou Lemmon Stohlman '34, "The alumnae shone." They held 54 social functions in cities across the United States and raised \$5,000 more than their goal of \$100,000.

However, the students raised more than the alumnae did for the campaign. Again, from <u>The Story of Sweet</u> Briar:

With characteristic imaginativeness of students, they employed ingenuity in bringing in nickels and dimes and quarters; they painted cartoons on slickers, cut each other's hair, conducted classes in reducing exercises, and one girl sold a new type of toothbrush invented by her father. Income from these projects and cash gifts from those who could afford them brought more than \$115,000. (pp 162-3)
