

Tax Reform Update: Key Takeaways

With the increase in standard deductions, it is estimated that fewer people will itemize in the future. The donor group most affected will be middle-income families and individuals. There is no evidence yet that the charitable giving of this group will decrease, or how much it could impact giving to education.

Higher-income donors, whose gifts are roughly 80% of all charitable dollars, will continue to itemize. It is expected there will be less impact on their giving.

A rise in the exemption for estate taxes may have an impact on higher-level donors making planned gifts. However, this can be offset by the increases in ways to give now, including the IRA rollover and the proposed change on restrictions on donor advised funds to allow DAFS to be used to satisfy pledges in some

cases. (Stay tuned for more on this topic.)

Bottom line: tax deductibility is not the top giving motivator for most donors, and this is all the more true for those who believe in the mission and know their gifts are essential to sustaining the organizations they support. So keeping our alumnae and friends in the circle about Sweet Briar's strategic direction is a high priority.

The rise in the stock market has put many investors in the position of holding highly appreciated stocks, just as upturns in the housing market have caused property values to rise, which also can lead to properties being appreciated in value. Sweet Briar welcomes the opportunity to discuss with you and your advisor the ways that you can make your gift to the College in 2018.

Sweet Briar recognized for strategic initiatives with upgraded rating from S&P Global

S&P Global Ratings announced yesterday that it has raised its long-term rating to "B+" from "B" on bonds issued for Sweet Briar College, with an outlook of "stable."

"The rating upgrade reflects our view of the college's new board and senior leadership team, including a new president who officially took office in May 2017, who have taken a number of actions to stabilize the college following the previously announced closure of the college in March 2015," according to S&P Global's report.

"These actions include an overhaul of strategic initiatives and developing

related objectives to address the college's immediate and intermediate priorities that include curriculum restructuring, reexamination of SBC's tuition policy, and implementation of multi-year planning. In addition, during fiscal 2017, the college refinanced its direct placement debt with a loan from the endowment, thereby eliminating acceleration risk, which had been a prior credit concern."

S&P further noted that Sweet Briar's "continued elevated fundraising support and astute financial management and budgeting practices support the college's attempt to

stabilize and sustain its operations."

In September, the College announced a comprehensive vision focused on excellence, relevance and affordability, and positioned itself as a new business model for liberal arts institutions. Comprehensive tuition, fees, room and board were reduced by 32 percent to \$34,000 for the 2018-19 academic year.

Lynn Rainville named associate dean of academic affairs at Sweet Briar

Research professor Lynn Rainville has been named associate dean of academic affairs at Sweet Briar College. She will continue in her role as director of the Tusculum Institute.

In her new role, Rainville will be the College's point person for its library, sponsored research, the Honors Program, institutional effectiveness and study-abroad opportunities. "I'm grateful to Lynn for her willingness to take on this role and ensure that these important aspects of our educational community continue to get the attention they deserve," said Dean of the College Rob Granger. "In addition, she understands the importance of the humanities and social sciences at Sweet Briar and I look forward to her good counsel."

A nationally recognized authority on African-American history and overlooked communities, Rainville joined the Sweet Briar College community in 2001, teaching anthropology and archaeology courses. Since then, she has received a number of awards and grants, including a National Endowment for the Humanities grant in 2005 that enabled her to investigate historic African-American cemeteries in Virginia.

"Sweet Briar has been fertile ground for studying our shared and complicated past," Rainville said.

In 2008, she was asked to lead the new Tusculum Institute for historic preservation and public history. In that role, she has worked on ethno-historic research and, together with the Virginia Department of Historic Resources, worked to promote environmentally sustainable historic preservation initiatives throughout the Commonwealth. She will continue to work on these projects as part of her new duties.

Rainville attended Dartmouth College, where she



double-majored in history and anthropology, was a member of Phi Beta Kappa and graduated magna cum laude. She earned her Ph.D. from the University of Michigan in Near Eastern archaeology and spent more than a decade directing projects in Turkey and Syria. For the last 17 years, she has been uncovering Virginia's forgotten histories, including research into enslaved communities, poor farms, and the state's role in World War I. Her work has appeared in four books and more than two dozen articles. She has shared her research with Sweet Briar students, as well as large public audiences, through regular public lectures, online databases and social media.

Rainville has held leadership positions in several community and professional organizations, including the National Database of Enslaved Americans, Preservation Piedmont, the Virginian WWI/WWII Centennial Commission and the Virginia History Forum. She has also served as a guest curator at several museums and historical societies, as a fellow at the Virginia Foundation for the Humanities and a National Lecturer for the Archaeological Institute of America.

Sweet Briar College and Girl Scouts announce scholarship for Gold Award achievers

Sweet Briar College has announced a new scholarship in partnership with the Girl Scouts of the USA for girls who have completed the Gold Award. The announcement was made at the Virginia Skyline Council's Gold Award Ceremony on Saturday, Dec. 16, in Roanoke.

"Sweet Briar College and the Girl Scouts share a commitment to supporting young women who are go-getters, innovators, risk-takers and leaders. With these values in common we have come together in a national partnership to establish a Girl Scouts Gold Award Scholarship at Sweet Briar College," said Melissa Farmer Richards, vice president for communications and enrollment management at Sweet Briar College.

Two awards, each valued at \$2,500, are available for eligible incoming first-year students who have achieved the Girl Scout Gold Award. One is designated for a student who is a member of a Girl Scout troop in Virginia, while the other is open to a Girl Scout troop member anywhere in the United States.

The scholarship is renewable for four years of study at Sweet Briar if a grade point average of 3.0 is maintained. Scholarship winners will be judged on the following criteria:

- Acceptance to Sweet Briar College and a commitment to attend
- 2. Current (or recent) active membership in a Girl Scout troop and completion of the Girl Scout Gold Award (Please provide copy of the certificate or letter)
- 3. Letter of recommendation from the troop leader
- 4. Essay on how you have demonstrated a commitment to community service, leadership and/or sustainability

The scholarship is funded by several generous Sweet Briar alumnae who are former Girl Scouts and who care deeply about advancing women's leadership.

"The Girl Scouts of Virginia Skyline Council is

honored that Sweet Briar College will announce this new scholarship initiative at our Gold Award Ceremony so that our girls will be among the first to know they are eligible," said Nikki Williams, chief executive officer for Girl Scouts of Virginia Skyline. "Sweet Briar's new core curriculum focused on women's leadership and the Girl Scout leadership experience have a compelling synergy."

In September, Sweet Briar announced a reduced tuition of \$21,000 for the 2018-2019 academic year, now competitive with public institutions. The goal is to make the cost of attending a private institution more transparent by eliminating the confusion over discount rates, a term that describes how institutions discount published rates. Sweet Briar's 32 percent tuition reduction is part of a comprehensive "reset" in the College's pursuit of academic excellence, relevance and affordability. Sweet Briar has been recognized nationwide for announcing plans to replace its general education curriculum with a core set of courses focused on women's leadership.


2017's Successful
